***Re: Poll Shows Deep Opposition to Bush Privatization Plan Among Voters Represented by Undecided Members of House Ways and Means Committee***

A new poll conducted by SCG Research for the USAction Education Fund has found deep opposition to President Bush's plan to privatize Social Security. The poll was taken among voters represented by nine undecided members of the House Ways and Means Committee. Almost seventy percent of these voters oppose the President's plan for Social Security.

69.63% of voters surveyed in the nine Congressional Districts, including Congressman Chocoma's 2<sup>nd</sup> District in Indiana, opposed the Bush plan.

The poll also found that 68.46% of voters said they were less likely to vote for candidates who support the President's plan for Social Security.

The automated poll, sampled the opinions of 3,018 registered voters in nine Congressional Districts represented by Members of Congress who have not yet indicated their position on the President's Social Security privatization proposals. These included CO-7, CT-5, FL-16, FL-22, IA-1, IL-11, IN-2, MN-3 and PA-3.

The nation wide poll was conducted between July 14 and 20 and has a margin of error of +/- 1.8%.

Key findings include:

- By a margin of 69.58% to 30.42%, voters in these districts said they disapproved of President Bush's handling of Social Security.
- Seventy One percent of these voters think the Bush Social Security plan will cut their Social Security benefits.
- Sixty Nine percent think the Bush plan will make Social Security weaker.
- Over sixty nine percent say they oppose the President's plan for Social Security.
- Sixty Eight percent said they would be less likely to vote for a candidate who supports the Bush Social Security plan.

The results for voters in Indiana's 2<sup>nd</sup> CD closely mirror results in other Districts represented by undecided Ways and Means Committee Members.
